

Cisco College Board of Regents  
Special Called Meeting/Public Hearing  
September 15, 2025

The Cisco College Board of Regents met Monday, September 15, 2025, in the Board Room of the Regents' House on the college main campus in Cisco, Texas. Officers in attendance were President Brad Kimbrough, Vice President Rick Watts, and Secretary Ricky Whatley. Regents present were Jerry Conring and Greg Cary. Regents Kyle Wilks, Jayln Johnson, Staci Wilks, and Kenneth Preston were absent. College administrators present were Dr. Thad J. Anglin, President, and Ms. Audra Taylor, Vice President of Business Services and Chief Financial Officer. Sydni Rabb, Executive Assistant, was present.

Guests present at the meeting included Dr. Helen Usera, Executive Director of Development and Grants; Dr. Tim Murphy, Executive Director of I.T.; Sheron Caton, Dean of Distance Education; and William Vaughan, Executive Director of Institutional Effectiveness and Planning.

Regent Greg Cary offered the invocation.

President Kimbrough called the meeting to order at 5:45 p.m.


President Dr. Thad Anglin read the notice of tax revenue increase. The Cisco College Tax District will conduct a public hearing on September 15, 2025, on a proposal to decrease the tax rate, but increase the total tax revenues of the Cisco College Tax District from properties on the tax roll in the preceding year. The total tax revenue proposed to be raised last year at last year's tax rate of \$.2100 for each \$100 of taxable value was \$1,717,282. The total tax revenue proposed to be raised this year at the proposed tax rate of \$.2000 for each \$100 taxable value is \$2,154,795. The proposed tax rate is greater than the no-new-revenue tax rate and below the voter-approval rate. This means that Cisco College is proposing to increase property taxes for the 2025 tax year. The Cisco College Board of Regents is scheduled to vote on the tax rate that will result in that tax increase at a public meeting to be held on September 15, 2025, at the Regent's House, Cisco, Texas at 6:00 p.m.


The next board meeting is September 15, 2025, at 6:00 p.m.
