A tax rate of \$0.218000 per \$100 valuation has been proposed by the governing body of Cisco College.

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for Cisco College from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that Cisco College may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that Cisco College is proposing to increase property taxes for the 2023 tax year.

A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON September 11, 2023 AT 6:45PM AT 101 College Heights, Cisco TX 76437 Regent's House.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Cisco College is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the of Cisco College at their offices or by attending the public hearing mentioned above.
